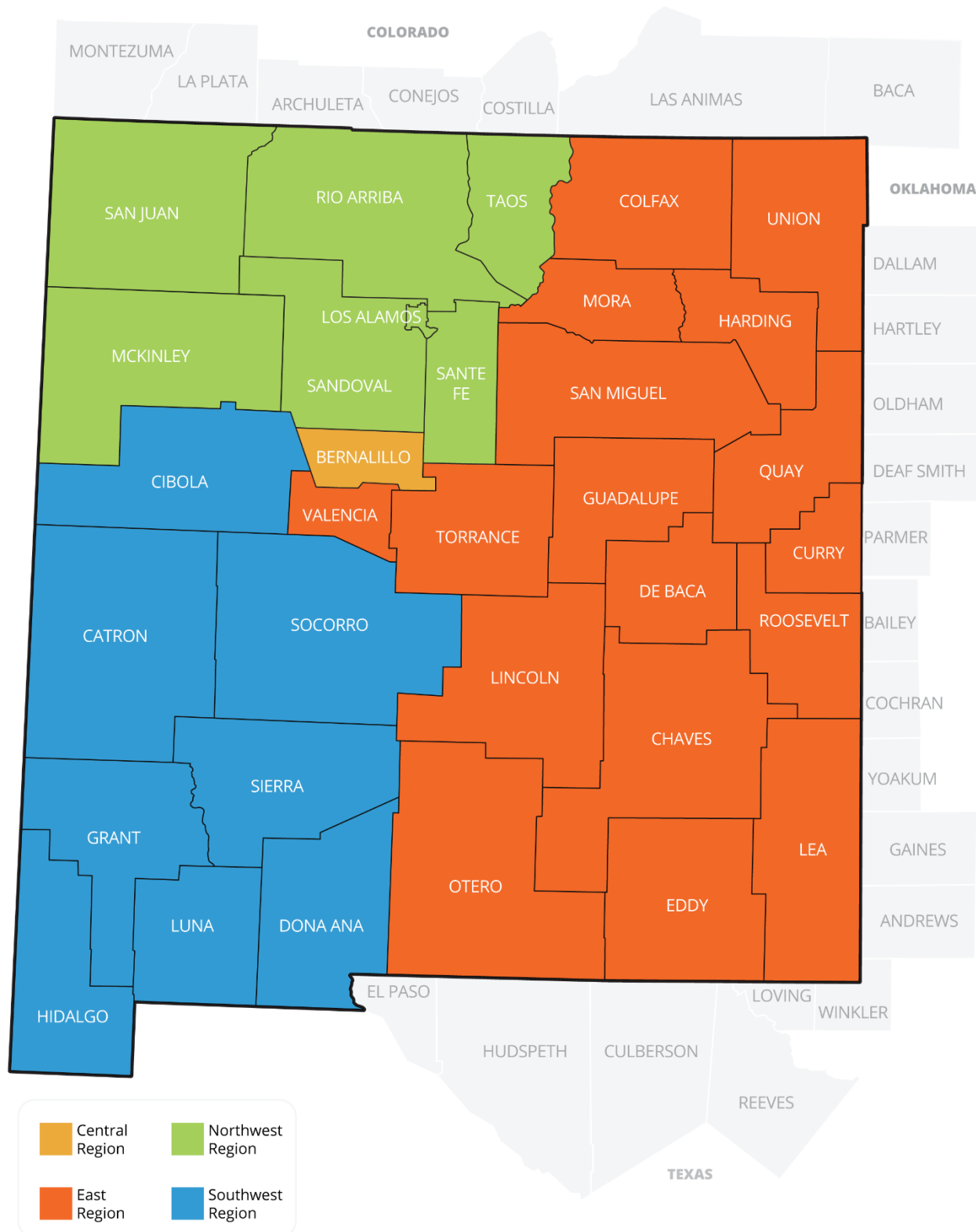

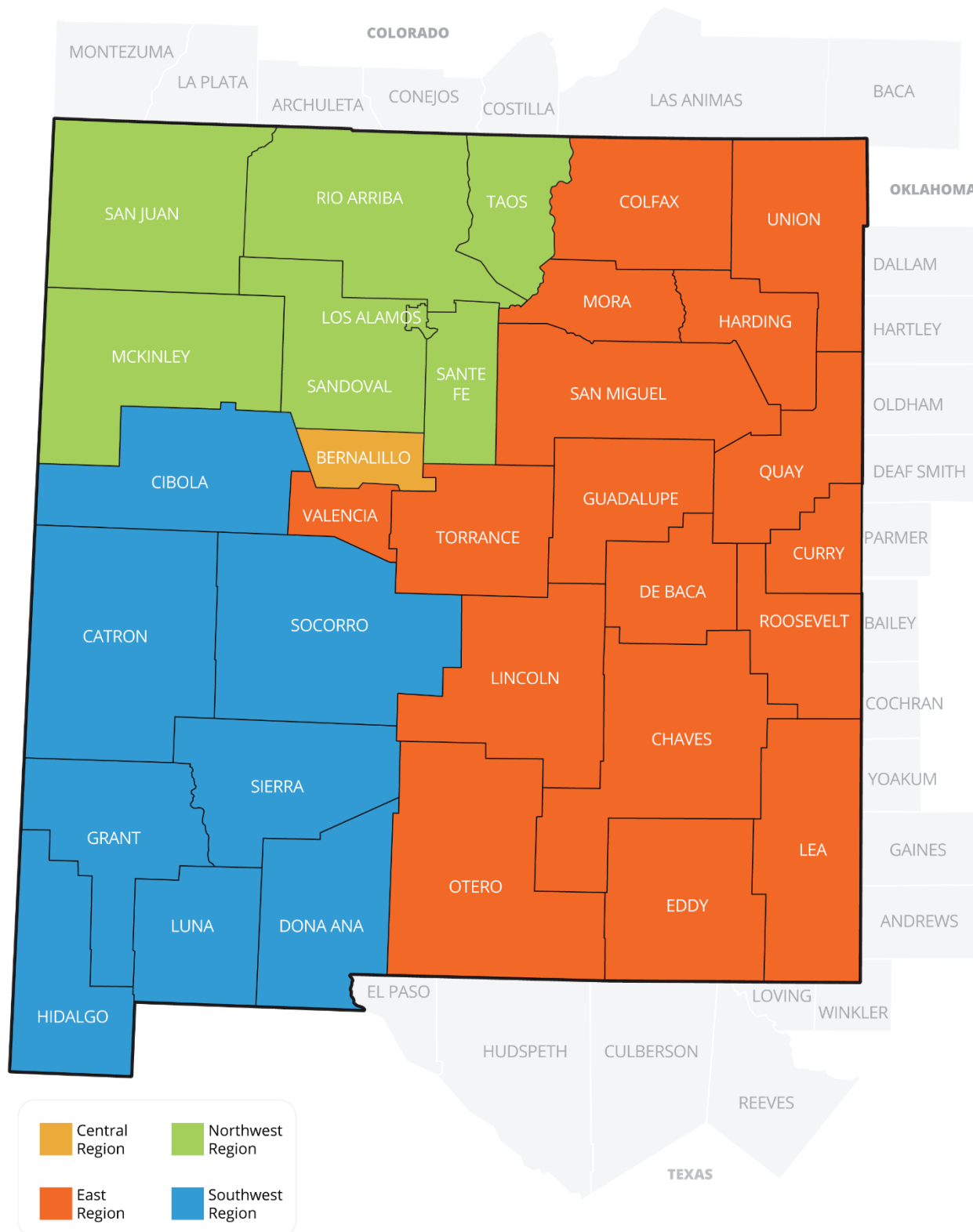

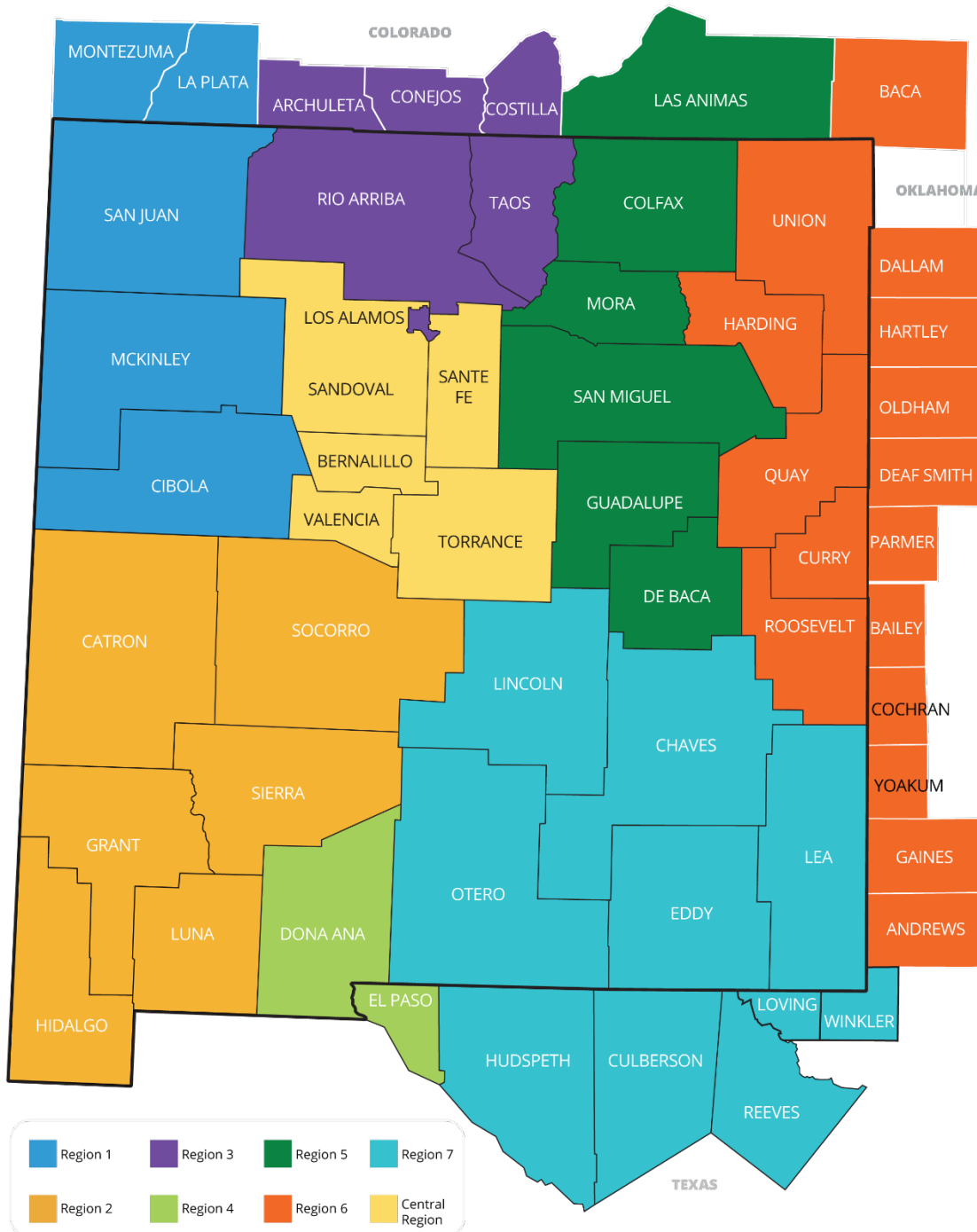


Network Representative Regions – LTC/DME
