Behavioral Health Covered Services

The Integrated Behavioral Health Program includes:

- Care/Utilization Management for inpatient, outpatient and partial hospitalization and residential behavioral health care
- Condition Case Management (seven conditions) depression, alcohol and substance abuse disorders, anxiety and panic disorders, bipolar disorders, eating disorders, schizophrenia and other psychotic disorders, and attention deficit and hyperactivity disorder
- Intensive case management
- Patient safety program
- Peer support

- Available to all Blue Cross Community Centennial members
- Team made up of Care Coordinators and Peer Support Specialists
- BCBSNM works with New Mexico's Behavioral Health Collaborative
- Behavioral health care management integrated into member medical care management program

Identification of Substance Use Disorder and Serious Mental Illness

BCBSNM has internal Peer Support Specialists who can help engage members with complex needs.

- They use their lived experiences to help members meet their treatment goals and try to engage them in required treatment.
- They can help providers identify needed resources for members who struggle with Mental Health and Substance Use needs.

BCBSNM has an assigned liaison for each psychiatric facility. These liaisons help facilities and members with discharge planning to identify gaps, barriers and resources.

They make sure appointments are set and help with any needed transportation. Their goal is to help members with a more successful discharge back to the community. If you have identified a member who needs extra help with their mental health and/or substance use needs, please contact BCBSNM Member Services at 1-866-689-1523, and ask to speak to a Behavioral Health Coordinator or a Recovery Support Assistant.

Behavioral Health Rosters

- Provider groups are to use the New Mexico Human Services Department-approved roster template for provider additions, terminations, demographic and location changes
- Rosters eliminate the need for separate provider applications
- Eligible Providers:
 - Core Service Agencies (CSA)
 - Community Mental Health Centers (CMHC)
 - Supervisory Certification (including Supervisory Protocol and Bils4Nils)
 - Applied Behavior Analysis (ABA)
 - All other providers must complete and submit Provider Interest Form
- Providers are to submit Behavioral Health Rosters to NetworkRosterSubmission@bcbsnm.com
