#### PREMIUM INFORMATION

Blue Cross and Blue Shield of New Mexico can only raise your premium if we raise the premium for all policies like yours in the state. We will not change your premium or cancel your policy because of poor health. Premiums change at age 65 and every year thereafter up to age 100. If your premium changes, you will be notified at least 60 days in advance.

#### Gender

One factor that will determine your premium is your gender. When completing the application, you will need to make a gender selection.

#### **Tobacco User**

A Tobacco User is a person who is permitted under state and federal law to legally use Tobacco, with Tobacco use (other than religious or ceremonial use of Tobacco) occurring on average of four or more times per week that last occurred within the past six months. Tobacco products include but are not limited to: cigarettes, cigars, smokeless tobacco products, electronic cigarettes, dissolvable tobacco products, vaping, etc.

If you meet the definition of a Tobacco User, you may pay a higher premium for your health coverage.

#### PREMIUM DISCOUNTS

A Blue Cross and Blue Shield of New Mexico Medicare Supplement premium discount may be available. Eligibility criteria are described below. If you are eligible for a discount, the discount will be applied to your next bill and remain in effect as long as you are enrolled in your Blue Cross and Blue Shield of New Mexico Medicare Supplement plan. Discounts cannot be combined; only one type of discount per member is permitted.

#### **Household Discount**

You may be eligible for a discount if you reside with a spouse or civil union/domestic partner OR have resided with as many as three adults age 60 or older for the last 12 months. Applies to Blue Cross and Blue Shield of New Mexico Medicare Supplement policies issued with an effective date on or after May 1, 2019. The discount is 10%.

#### **Continue with Blue™ Discount**

You may be eligible for a discount if you enrolled in a BCBSNM Medicare Supplement policy issued with an effective date on or after April 1, 2022 and you were enrolled in a Blue Cross and Blue Shield commercial group or individual health insurance coverage plan and that coverage was within one year of your BCBSNM Medicare Supplement policy becoming effective. The discount is 7%.

#### **Blue Family Discount**<sup>™</sup>

You may be eligible for a discount if you enrolled in a BCBSNM Medicare Supplement policy issued with an effective date on or after April 1, 2024 and you meet the criteria for both the Household Discount AND the Continue with Blue Discount. The discount is 12%.
